

Amendment of Declaration of Covenants, Conditions, Easements and Restrictions for Lonesome Dove Subdivision

Background

The membership of the River District Homeowner's Association, Inc. (the "Association") desire to amend the terms of the Declaration of Covenants, Conditions, Easements and Restrictions for Lonesome Dove Subdivision, recorded December 10, 2008, as Instrument 108131523 in the Records of Ada County (the "Master Declaration"), as supplemented by Instrument 108134326. The Master Declaration permits amendment by a document signed and acknowledged by the Owners, pursuant to Article XVI, Section 16.2. All capitalized terms, unless otherwise defined in this Amendment, are defined as in the Master Declaration.

Amendment

The Master Declaration is amended as follows:

1. A new Article VIII (Homeowner's Association), Section 8.4 is adopted, and the prior version is removed in its entirety. Section 8.4 shall now read:

8.4 **Voting**: Each Member shall be entitled to one (1) vote for each Lot owned. When more than one (1) person is an owner of the same Lot, all such persons shall be Members. The vote for such Lot shall be exercised as its owners determine, but in no event shall more than one (1) vote be cast with respect to any one Lot. The Association may rely on the representation of any one Member that the Member is authorized to vote on behalf of a Lot.

2. A new Article XIV (Specific Lot Uses and Restrictions), Section 14.4 is adopted:

14.4 **New Phases**: Any phase or Lot annexed into the Association after the date of this Amendment shall be subject to a 25% rental cap. All leases for the new phases must be approved in advance by the Association, and the Association may use its enforcement powers to ensure that at no time more than 25% of the number of lots in any new phase is rented, in whole or in part, to someone other than the title owner. The Association may make accommodations and exceptions to this rental cap, in its sole discretion, based on military status or legally-protected status of an applicant.


3. A new Article XVI (General Provisions), Section 16.4 is adopted:

16.4 **Rental Limitations:** All owners, by accepting title to a Lot in this subdivision, agree and consent to the following rental limitation. The rental of any Lot, in whole or in part, for any period of time, may be restricted by the Association from time to time. Such restrictions shall not apply to Lots currently in the Association, but shall apply as soon as any new owner takes title to any Lot, or as soon as any Lot is subdivided or annexed into the Association after this Amendment is recorded.

4. Further, any and all provisions purporting to grant rights, powers or privileges to the Declarant or its successors or assigns are hereby removed in their entirety, whether or not they have been enumerated specifically in earlier sections of this Amendment. This includes, but is not limited to, the removal of any voting by class, any rights to annex property, and any rights to veto the actions of the members of the Association. This includes, but is not limited to, the removal of Article IV, Article XII, all of Section 8.2 and portions of Section 10.1.




